4. Provide a brief summary of the background and the purpose of the actual question being proposed. Why is this AHRQ being proposed? (e.g., development of guidelines on improving prevention and care delivery of a specific chronic disease.)

The Sub-Acute Unit for Frail Elderly (SAFE Unit) based at the Perley and Rideau Veterans' Health Centre was implemented in order to address the capacity issue that exists in hospitals due in part to elderly patients occupying a high proportion of acute care beds. Many of these patients could be safely cared for in other settings. Under SAFE, these patients transfer from an acute-care hospital to a special 20-bed unit at the Perley and Rideau Veterans' Health Centre, where they access the medical and rehabilitative supports needed to recover fully and return to their place of residence.

The Centre of Excellence and Research Operations at the Perley and Rideau Veterans' Health Centre is interested in evaluating the effectiveness, as well as the cost effectiveness of the SAFE Unit in improving patient care and outcomes. Key outcomes of interest include: ED visits; hospital readmissions; visits to a family doctor; receipt of home care support; and long-term care admission. A cost-analysis will help determine the feasibility of the model and help inform future planning for scaling up and spreading the program.

Using ICES data, we will be able to examine the patients' outcomes, health service utilization and the associated costs of care following discharge from an acute care hospital. This will inform the cost-effectiveness and sustainability of the program.

5. What is the current status of knowledge by the Knowledge User group? (e.g., there is some anecdotal evidence that the existing delivery of services do not adequately capture high-risk groups.)

Evidence shows that an acute care setting is not appropriate for frail seniors to recover from acute illness and puts them at risk of worsening frailty status. The SAFE Unit at the Perley and Rideau Veterans' Health Centre aims to reduce acute care length of stay for frail elderly by providing them care that is more appropriate and cost-effective. By providing specialized short-term care to medically complex frail elderly, it is expected that they will be able to return home with appropriate supports. In turn, they may be able to avoid unnecessary ED visits and hospital admission as well as delay in long-term care admission in the future.

6. How will the eventual research evidence be used and what purpose will the proposed research serve? (e.g., the research evidence will be reviewed by senior management and service delivery partners and considered in the development of a defined preferred model of care and best practice relating to a health care issue.)

The evaluation will determine whether a transitional care model like the SAFE Unit is an effective and sustainable solution to caring for frail elderly persons following their discharge from an acute care hospital. Evidence from this research will help inform future programming for the SAFE Unit at the Perley and Rideau Veterans' Health Centre and decisions by the Ontario Ministry of Health and Long-Term Care in allocating resources to provide the types of support needed by seniors with complex needs.
